Press Release

From October 21-25, 2019, the fourth edition of the African Microfinance Week (SAM) was held in Ouagadougou under the theme "pathway toward Impact: African inclusive finance for the Sustainable Development Goals".

Inclusive finance is booming in Africa. Since 2017 SAM, we have not counted the significant effects of this sector, which has developed promising innovations and greatly increased both in terms of intersectoral collaboration and achievement of the United Nations Sustainable Development Goals (SDGs).

Inclusive finance is therefore seen as a promising solution to remove some obstacles to achieving the SDGs, especially as the sector is undergoing a transformation with the digital revolution.

SAM is an international conference dedicated to the development of financial inclusion in Africa. It is open to all microfinance practitioners and is co-organized by MAIN (Microfinance African Institutions Network), AFRACA (African Rural & Agricultural Credit Association) and ADA, a Luxembourg NGO specialized in inclusive finance supported by the Development Cooperation and Humanitarian Action of the Grand Duchy of Luxembourg.

The conference took place at Ouaga 2000 International Conference Center and brought together more than 900 participants from 54 countries, including 35 from Africa. SAM brings together African microfinance professionals into a forum for debate and exchange. Above all, it facilitates meetings by opening up to other stakeholders, politicians, investors, innovators, entrepreneurs and others. It thus contributes to the evolution of financial inclusion in Africa in a changing world. Several key events marked this 4th edition of the SAM namely: the village of the innovators, the investors fair, the trainings, research meet Africa, and the general assembly of MAIN.

Thus, on October 25, 2019, MAIN held its 9 th General Assembly (GA) of members which took place at the international conference center of Ouaga 2000. The General Assembly brought together 60 members from Togo, Burkina Faso, Ethiopia, Rwanda, Guinea, Benin, Uganda, Burundi, Morocco, Mali, France, Cameroon, Madagascar, DRC, Italy, Kenya, Senegal, and Congo Brazzaville.



During this GA, all the different items on the agenda were examined. The assembly, having received answers to its various requests for clarification, approved all the reports (activity reports and management reports for the years 2017 and 2018, audit report, action plan and budget 2020-2022, etc.). Regarding the new memberships, the network admitted, during the period from January 2017 to December 2018, twenty-eight (28) new members from 16 countries. This demonstrates the growing interest of new institutions to MAIN network.



The GA was the occasion for the renewal of the members of the board of directors. Five new members were elected by vote. Two of the three founding members are statutory members of the Board of Directors on a rotating basis. The new board is composed as follows:
